

2017: Fidelity Federal Municipal Funds Interest Dividends by Month

You may need this information to prepare your state income tax return. If, during 2017, you owned shares of any of the Fidelity funds listed in the tables that follow, then a portion of the federal tax-exempt interest dividends you earned may be exempt from your state's income tax.

The enclosed tables provide information for exempt-interest dividends earned from January 2017 through December 2017. Dividends declared in December must be reported as income in the year declared, even if they are paid the following January.

To determine the portion of your tax-exempt interest dividends that may be exempt from your state's income tax, multiply the total tax-exempt interest dividend you received from the fund as of the end of each month, as shown in the Transaction Details section of your monthly or quarterly statements, by the percentage of interest received from your home state plus, if applicable, the U.S. territories. Although state tax laws differ, many states do not tax interest on the bonds they issue or on municipal bonds issued within the same state. Interest income from securities issued by U.S. territories and possessions is exempt from federal, state, and local income tax in all 50 states. For this reason, you should add the percentages listed for any U.S. territories or possessions to the percentage for your given state.

The following example shows how a Massachusetts investor who purchased shares of Fidelity® Intermediate Municipal Income Fund in October 2017, and earned \$1,000 in exempt-interest dividends per month in October, November, and December, would calculate the portion of the interest dividends that may be exempt from state income tax.
