

# Tax Year 2012: Important Information for Massachusetts Residents



This information may assist you in preparing your Massachusetts state income tax return.

If during 2012 you were subject to tax in Massachusetts and held shares of the **Fidelity® Massachusetts Municipal Income Fund**, the table below lists the percentages of any federally taxable distributions you received from this fund that may be exempt from Massachusetts state income tax. These distributions that may be exempt from Massachusetts state income tax represent exempt gains realized by each fund on the sale of certain securities.

To determine the amount of each capital gain distribution that may be exempt from Massachusetts state income tax, multiply the amount you received for each distribution listed in the table below by the exempt percentage. The amount of each capital gain distribution you received is reported:

- For **Fidelity brokerage accounts**, in the Supplemental Information portion of your 2012 Tax Statement—find the Details of 1099-DIV Transactions, Total Capital Gains Distributions Detail, column 2a.
- For **Fidelity mutual fund accounts**, in the Transaction Details section of your 2012 year-end Investment Report or your applicable monthly/quarterly account statement.
